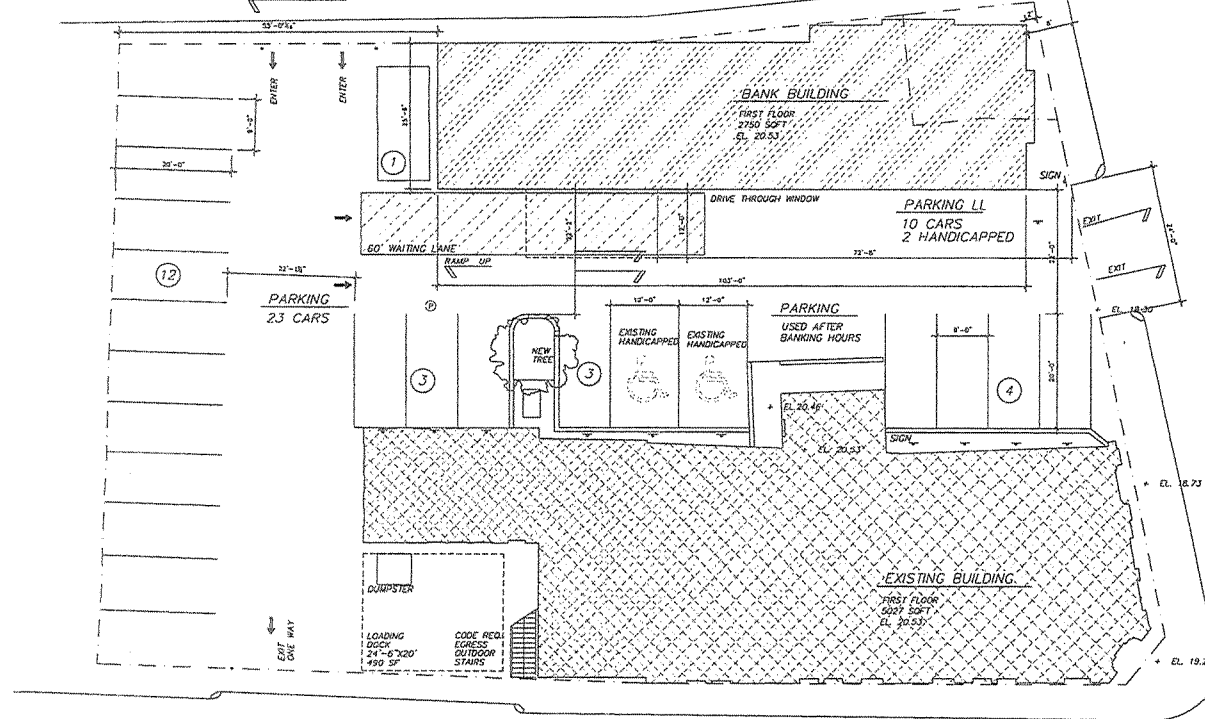

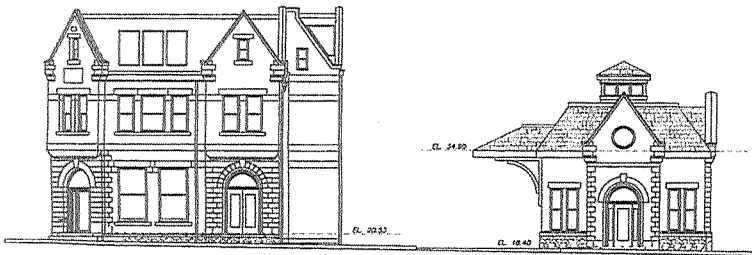

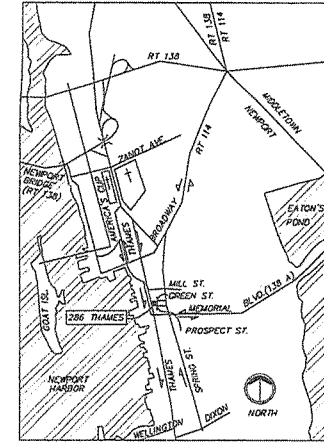

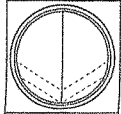
LOCUS MAP

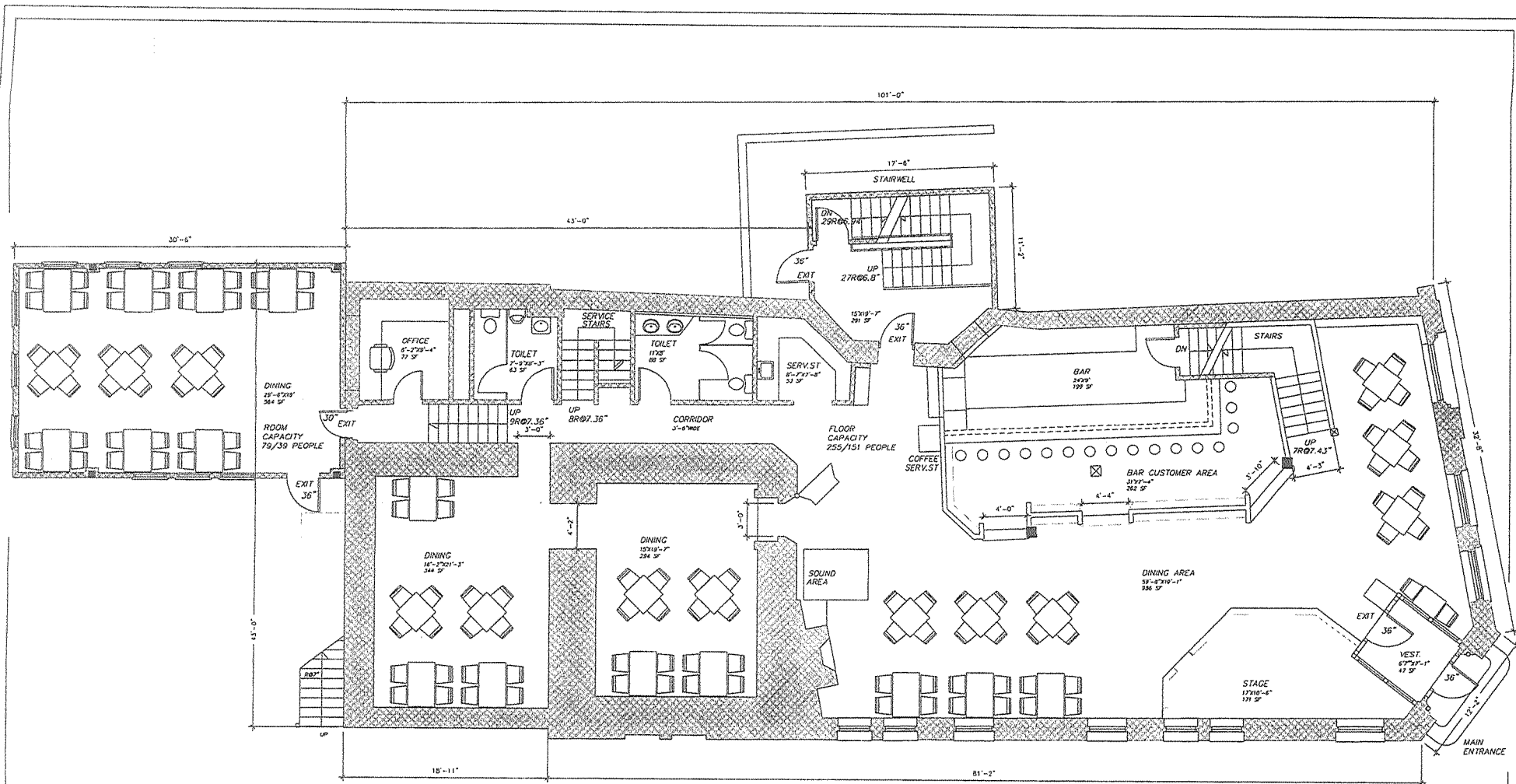

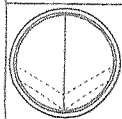
