RECOMMENDATION:

City Administration recommends approval of a resolution authorizing the filing of the annual Community Development Block Grant Application on behalf of the City with the State of Rhode Island's Department of Administration, Office of Housing and Community Development.

BACKGROUND AND FINDINGS:

The City of Newport is considering the filing of its annual application for a RI Small Cities Community Development Block Grant (CDBG) Program under the U.S. Housing and Community Development Act of 1974. This year, the 2020/21 Grant Year, will be the 43nd year the City has participated in this program. The primary purpose of the CDBG Program is the development of viable urban communities through the provision of decent housing, suitable living environments, and expanded economic activities, principally for persons of low and moderate-income.

The Application includes planned activities in the amount of \$570,000, not including funding to support CCHC' Lead-Based Paint Hazard Evaluation and Reduction Program, with an eligible administration amount to be determined.

During the course of the annual CDBG application process, the City is required to conduct two public hearings. The First Public Hearing was held virtually on February 2, 2022. The Second Public Hearing will be held at the February 23, 2022 virtual City Council Meeting.

At the regularly scheduled meeting held on February 3, 2022, the Newport Planning Board certified that it reviewed the proposed activities, been given the opportunity to comment on them, and that to the best of their knowledge, the activities "are not in conflict with the general policies set forth in the Comprehensive Plan."

A resolution approved by the City Council is a required element of the application. The wording of this resolution has been established by CDBG Program Regulations and should generally not be changed.

Dear Ms. Daugherty,

The Edward King House, along with the City of Newport, is seeking your support in efforts to improve the electrical infrastructure and upgrade the existing light fixtures to new energy efficient light fixtures. Completion of this work will ensure that the electrical service is sufficient to support the new light fixtures, as well as other planned improvements. The new light fixtures will provide for energy efficiency while improving lighting in areas used for public events. This will support the healthy environment provided for the elderly population that is served at the Edward King House.

We plan to request \$350,000.00 for this work, to include an upgrade of the existing electrical service to 800 Amp, 120/208V service, installation of new panels for the existing service, and upgrade all light fixtures (78 total) to new energy efficient fixtures.
