#### **RECOMMENDATION:**

The Department of Utilities, Water Pollution Control Division staff, recommends the award of Amendment No. 4 per Section X. Supplemental Agreements of Contract #16-040 with Fuss & O'Neill for Engineering Services for Drainage Investigation and Flooding Analysis for the Whitwell Avenue Area for an amount not to exceed \$60,600. Amendment No.4 will fund the engineering services and assist with developing nonstructural approaches to reduce stormwater impacts Citywide. Funding for Amendment #4 will be financed by the Water Pollution Control Division Capital Program. It is also recommended that the term of Contract #16-040 be extended to July 1, 2023.

#### **BACKGROUND AND FINDINGS:**

During high-intensity rain events, the City experiences several areas of localized flooding in low-lying areas. These events result from three major factors: the evolution of modern stormwater engineering, urbanization of the watershed, and climate change. The City has completed numerous Drainage Investigations and Flooding Analyses with common results. No simple solution exists, and stormwater mitigation will require a comprehensive management approach with a combination of public and private projects, adaptation, operation, and maintenance.

The 2019 SNEP Watershed Grant program funded Amendment #2 services associated with implementing the work plan for developing nonstructural approaches to reduce stormwater impacts in an urban neighborhood such as the Whitwell Avenue study area. During this project, it was found that the Whitwell Watershed was adding an average of 1 acre new impervious cover per year resulting in 133,000 extra gallons of flow per design storm.

This trend is occurring Citywide to varying degrees. The proposed amendment will quantify the annual rate of new impervious areas and the associated increase in runoff Citywide for 2018, 2019, 2020. Concurrent with the engineering analysis, a draft onsite City Stormwater Ordinance will be evaluated. The process will assess the current regulatory structure, feasibility, legality, and public outreach.

In consideration of the mutual promises herein contained, the parties hereto agree to amend their Agreement dated April 25, 2016 as follows:

#### PROJECT UNDERSTANDING

The purpose of this amendment is to create additional deliverables building upon the City of Newport's 2019 Watershed Grant funding through the Southeast New England Program. The purpose of this amendment is to develop a citywide ordinance that will reduce stormwater impacts from private properties through regulation and small-scale physical property owner education to reduce stormwater volumes and pollutants.

#### SCOPE OF SERVICES

Fuss & O'Neill proposes the following scope of services to assist the City through preliminary design phase for these improvements.

- 1. Task 1. Impervious Surface Area Estimate: Assess the average annual rate of new impervious surface area in Newport for the years 2018, 2019 and 2020 by evaluating building permit data provided by City staff from the Department of Building and Inspections.
- 2. Task 2. Stormwater Runoff Estimate: Assess the amount of resulting stormwater generated by the new impervious surface area created during the years 2018, 2019 and 2020 (during 2- and 10-year storm events).
- 3. Task 3. Draft Citywide Stormwater Ordinance
  - a. Review the existing conditions report, Draft Stormwater Management Overlay Zone ordinance, which was created for the Whitwell Avenue project area under SNEP grant, and the Homeowner's Guide to on-site stormwater management.
  - b. Assess the existing City regulatory structure for a recommended method for integration of On-site Stormwater Management Mitigation Requirement for additional impervious surfaces. This task also includes:
  - c. Assess the feasibility of stand-alone ordinance as an option, including an outline of the ordinance and existing ordinance models from other communities
  - d. Assess the feasibility of an amendment to an existing ordinance (potential Sediment and Erosion Control ordinance) as an option, including an outline of ordinance amendments and existing ordinance models from other communities.



- e. Assess the legality of both options within the context of the City legal structure and legal precedents at State and Federal levels. Research and cite the case precedents which support and/or erode the feasibility of both options.
- f. Make recommendation for preferred legal method.
- g. Prepare a memorandum summarizing our findings and recommendations.
- h. Meet with the Department of Utilities to review the memorandum and to develop next steps for enactment of the stormwater ordinance.
- i. Meet with the City Solicitor and Department of Utilities to review the recommended method to enact the stormwater ordinance.
- j. Prepare a draft stormwater ordinance for the City's review by the Department of Utilities and City Solicitor.
- k. Address minor review comments to amend the draft ordinance and submit a final stormwater ordinance to the City.
- l. Participate in four (4) public meetings/hearings to present/discuss the draft ordinance.

#### TERM OF AGREEMENT

Replace Part III of the Agreement with the following:

"Unless terminated earlier in accordance with the terms of this Agreement, this Agreement shall terminate on July 30, 2022. Throughout such time, all fees and work specifications as identified herein shall remain in effect."
